**Mr. Noordin AZHARI** is Deputy Chief of Party at the US-ASEAN Connectivity through Trade and Investment (US-ACTI). US-ACTI provides technical assistance and training to ASEAN members with the view to assist ASEAN realize the objectives of the ASEAN Economic Community. US-ACTI assists ASEAN through the following work streams/areas: ASEAN Single Window, trade and investment, small and medium enterprises, energy, and information and communication technology.

Previously, Mr. Azhari served as the Acting Chief of Party as well as Deputy Chief of Party of the ASEAN Technical Assistance and Training Facility from 2007-2013. He worked for the ASEAN Secretariat from 1983-1987 and 1994-2006. He was the Director of the Bureau for Economic Integration, ASEAN Secretariat from 2002-2006.



**Mr. Jerry BERNAS** is the Program Director of the ASEAN CSR Network (ACN), a regional organization formed in 2010 to help meet the ASEAN Community's strategic objective 'to promote Corporate Social Responsibility' under the ASCC (2009-2015). Jerry led the development of the strategic framework that led to the network's establishment and was its first full-time manager.

As Program Director, Jerry leads ACN's 'ASEAN CSR Vision 2020' initiative – which aims to mainstream responsible business conduct in ASEAN through advocacy, capacity building and catalyzing collective action. It is a multi-year program funded primarily by the Government of Sweden. He also oversees ACN's work on Business & Human Rights and Anti-Corruption.

Jerry has extensive expertise on CSR and related issues and has led projects and partnerships across the region with international NGOs, UN agencies, and the business community. His expertise is

enriched by over 14 years of experience working in the private and non-profit sectors, including as Executive Director of the League of Corporate Foundations (Philippines), Senior Manager at EON Stakeholder Relations Firm, and full-time community volunteer for the Jesuit Volunteers of the Philippines.

He holds a Master of Business Administration (MBA) degree, specializing in strategy and organization, from the National University of Singapore and Bachelor's degree in Management from Ateneo de Manila University (Philippines). Jerry is a Filipino national who currently resides in Singapore.



**Ms. Jessie BRUNNER** is the Program Manager of WSD Handa Center for Human Rights and International Justice, where she manages student programs, including the Minor in Human Rights and several research activities. Her research is currently focused on human trafficking prevalence data and prolonged solitary confinement. Brunner completed her master's degree in International Policy Studies at Stanford University, where she focused on global justice and served as a research assistant at the Center on Democracy, Development, and the Rule of Law's Program on Human Rights. Her research has also taken Brunner to Cambodia, Thailand, Indonesia, Rwanda, Argentina, Bosnia and Herzegovina, and Chile.

Previously, Brunner served as a Public Affairs Assistant at the State Department in the Bureau on Democracy, Human Rights and Labor, a reporter for Los Angeles Times Community News, a non-profit public relations/marketing manager, and a freelance writer. Brunner graduated with Highest Distinction from UC Berkeley with a BA in Mass Communications and a Spanish minor.



**Mr. Rafendi DJAMIN** is the Regional Director for South East Asia and Pacific of Amnesty International and the former Executive Director of the Human Rights Working Group (HRWG), a permanent coalition of Indonesian NGO's for International Human Rights Advocacy based in Jakarta. He served as the first Indonesian Representative for the ASEAN Intergovernmental Commission on Human Rights (AICHR) from 2009-2015, and held a position as the chair of AICHR in 2011. He received his Master's degree in Development Studies in 1989 from the Institute of Social Studies in The Hague, The Netherlands.

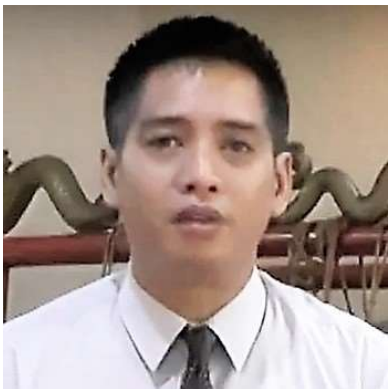

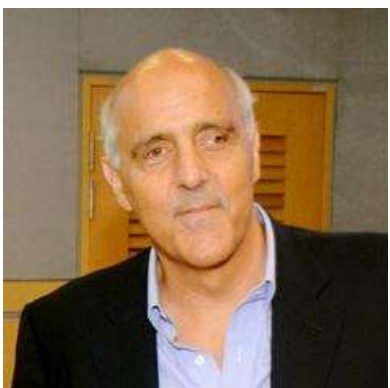
**Professor Mely CABALLERO-ANTHONY** is Associate Professor and Head of the Centre for Non-Traditional Security (NTS) Studies at the S. Rajaratnam School of International Studies (RSIS), Nanyang Technological University, Singapore. Until May 2012, she served as Director of External Relations at the ASEAN Secretariat. She currently serves as Chair of the UN Secretary-General's Advisory Board on Disarmament Matters and Security and is a member of the UN Academic Advisory Council on Conflict Prevention. She was also a member of the World Economic Forum (WEF) Global Agenda Council on Conflict Prevention until 2015.

Prof. Anthony's research interests include regionalism and regional security in the Asia-Pacific, non-traditional security (NTS), politics and international relations in ASEAN and East Asia, conflict prevention and management, as well as human security. She was the principal investigator of the MacArthur Asia Security Initiative (ASI) project of Internal Security Challenges in Asia and Cross-Border Implications.

She has published extensively in peer-reviewed journals on a broad range of security issues in the Asia-Pacific. Her latest publications, both single-authored and co-edited, include: *An Introduction to Non-Traditional Security Studies* (London: SAGE Publications Ltd, 2016), *Asia on the Move: Regional Migration and the Role of Civil Society* (Japan: JCIE, 2015), 'Understanding ASEAN Centrality' (*Pacific Review*, 2014), 'Human Security in ASEAN: 20 Years On' (*Asian Journal of Peacebuilding*, 2014), and *Non-Traditional Security in Asia: Issues, Challenges and Framework for Action* (ISEAS, 2013).



**Mr. Andhika CHRISNAYUDHANTO** is Deputy Director for Political and Security Treaties at the Directorate of Political, Security, and Territorial Treaties, Directorate General of Legal Affairs and International Treaties, Ministry of Foreign Affairs, Republic of Indonesia. He holds a degree in Master of Arts in Foreign Affairs and Trade, Business and Economics, from Monash University. He is also a graduate of Universitas Nasional (Indonesia), where he obtained degrees in law and political science. Andhika is involved in the formulation of a policy guide on criminalizing migrant smuggling.



**Professor David COHEN** is the Executive Director of the WSD HANDA Center for Human Rights and International Justice at Stanford University. David Cohen is a leading expert in the fields of human rights, international law and transitional justice.

Cohen taught at UC Berkeley from 1979-2012 as the Ancker Distinguished Professor for the Humanities, and served as the founding Director of the Berkeley War Crimes Studies Center, which moved to Stanford at the end of 2013 and became the WSD Handa Center for Human Rights and International Justice. Cohen is now a

visiting professor at Stanford, Professor in the Graduate School at UC Berkeley, and Professor of Law at the William S. Richardson School of Law, University of Hawai'i. His involvement in research in war crimes tribunals began in the mid 1990s with a project to collect the records of the national war crimes programs conducted in approximately 20 countries in Europe and Asia after WWII.

Since 2001, Cohen's work has largely focused on contemporary tribunals and transitional justice initiatives. Cohen has led justice sector reform initiatives and tribunal monitoring programs in Indonesia, East Timor, Sierra Leone, Bangladesh, Rwanda, and Cambodia. At the regional level, Cohen has worked closely with the ASEAN Secretariat and the USAID Technical Facility to the ASEAN Secretariat in forming and leading an expert group to create the Human Rights Resource Centre (HRRRC). Cohen serves as the Advisor to the Executive Director and the Governing Board of the Resource Centre and leads the Centre's research projects. Cohen also directs the Summer Institute in International Humanitarian Law and Human Rights. Professor Cohen received his JD at UCLA's School of Law, his PhD in classics and ancient history from Cambridge University, and an Honorary Doctorate in Law from the University of Zurich. He has been a Fellow at the Hoover Institution at Stanford University since 2009.



**Professor Harkristuti HARKRISNOWO** is a criminologist and senior Law Faculty member at the University of Indonesia (UI), leading the UI Center for the Study of Human Rights. She studied law at the University of Indonesia (S.H., LL.M.) and criminology at Sam Houston State University (M.A., Ph.D.).

Since 1999, Prof. Harkrisnowo has been a member of the National Law Commission and remains a frequent commentator in national media on the Indonesian legal system and law reform issues. She is a leading Indonesian authority on human rights, women's issues and a broad range of social concerns, touching on such areas as corruption, the police, and judicial performance.



**Mr. Andrew HARRINGTON** is Counter Trafficking Programme Manager at International Organization for Migration Timor-Leste. Originally from Ottawa, Canada, currently living and working in Dili, Timor-Leste, Mr. Harrington is a legal specialist who manages IOM's counter-trafficking portfolio in Timor-Leste. He has extensive international legal and project management experience on diverse human rights, development and justice issues, working with diverse United Nations Agencies, International Organizations, National Governments, and NGOs – including more than six years working in Timor-Leste.

Previously for IOM, Mr. Harrington conducted a technical review of the migration legal framework in Mozambique, conducted a similar review of the legal framework in the Federated States of Micronesia, and conducted high-level training for key Micronesian government counterparts on harnessing migration for development using bilateral and regional framework agreements.



In Timor-Leste, Mr. Harrington's past work includes legal research on the protection and prosecution framework relating to trafficking in persons, leading the drafting of a comprehensive national law to prevent, punish and combat against trafficking in persons (currently in final legislative phases in Parliament), and developing a national visa to provide a recovery period for international victims.

Presently, Mr. Harrington is managing the implementation of two US-State Department-funded counter trafficking projects. Under these projects, IOM is establishing a baseline on trafficking in persons instances and trends, providing hands-on technical capacity building using a training-of-trainers approach for law enforcement, service providers and key government counterparts, and supporting a number of national NGOs in providing data collection and direct victim support services.



**Professor Carolina G. HERNANDEZ** is Founding President and Chief Executive Officer of the Institute for Strategic and Development Studies (ISDS Philippines). She is also Professor Emeritus in Political Science at the University of the Philippines (Diliman), where she taught in 1964 until her retirement in 2006.

A founding member of the ASEAN Institutes of Strategic and International Studies (ASEAN ISIS), Council for Security Cooperation in the Asia Pacific (CSCAP), the Council for Asia-Europe Cooperation (CAEC), the Asia-Pacific Security Forum (APSF), and the Human Rights Resource Center, she has also served in the boards of various regional and global institutions, including the UN Secretary-General's Advisory Board on Disarmament Matters, which she chaired in 2009, Global Centre on the Responsibility to Protect, Global Development Network, the Governing Council of the International Institute for Strategic Studies, and the Multi-Sectoral Board of the Philippine Army's transformation roadmap (PA-MSAB).



**Mr. Phongsaysack INTHALATH** is the Chair of the Senior Labour Officials Meeting of ASEAN. He is also the Director General of the Labour Management Department, Ministry of Labour and Social Welfare of Lao PDR. Mr. Inthalath holds a Master's degree in economics, graduated from Kasetsart University, Bangkok, Thailand. He has more than 23 years of experiences in labour and social welfare issues, with extensive work in ministerial level.



**Dr. Shreyasi JHA** is an expert in women's rights, gender equality and sustainable development. She has extensive experience in conducting evaluation, policy research and managing programs at the World Bank, United Nations Development Programme (UNDP), and UN Women. Her recent work focuses on integrating a gender and human rights perspective in monitoring and evaluation. Most recently, Shreyasi was the Planning, Monitoring, and Evaluation Specialist at the UN Women Multi Country Office for India, Bhutan, Maldives and Sri Lanka. Prior to working with UN Women, Shreyasi worked with the UNDP's Human Development Report Office on

measuring gender empowerment and environmental sustainability for the Human Development Reports.

In addition to her policy experience, Shreyasi is an experienced trainer and educator. She specializes in designing and conducting M&E training and workshops for development practitioners from the government and bilateral agencies, and civil society organizations. She taught courses on quantitative and qualitative methodology, international economic development, and research design at the University of Pennsylvania, New York University and University of Texas at Austin.



**Mr. Miguel MUSNGI** is currently the Senior Officer of the Poverty Eradication and Gender Division in ASEAN Secretariat. Previously, he was a Senior Officer of the Disaster Management and Humanitarian Assistance Division supporting ASEAN's regional cooperation on disaster management and resilience. Prior to joining the ASEAN Secretariat, Mr. Musngi has worked at the Bangsamoro Transition Commission and provided technical and legal support to indigenous peoples organisations engaged in developing the Bangsamoro Basic Law. Mr. Musngi worked at Oxfam as a Regional Campaigner for Southeast Asia for the GROW Campaign and on several occasion as a

consultant on issues such as climate change, food price volatility, disaster risk reduction, and regional partnership. He also worked as a Programme Manager at the Konrad Adenauer Stiftung-Manila, working on political party reforms and local governance. For more than ten years, Mr. Musngi has worked with small farmers, rural women, and indigenous peoples in the Philippines advocating farmers' rights, women's rights, gender equality, indigenous people's rights, and development of agricultural policies such as rural credit to enhance their accessibility to marginalized groups.

Mr. Miguel Musngi has a Bachelor's Degree in Public Administration, and a Master's Degree in Public Policy from the National College of Public Administration and Governance, University of the Philippines, Diliman. He also has a Juris Doctor from the College of Law, University of the Philippines, Diliman.



**Ambassador ONG Keng Yong** is Executive Deputy Chairman of the S. Rajaratnam School of International Studies at the Nanyang Technological University in Singapore. Concurrently, he is Ambassador-at-Large at the Singapore Ministry of Foreign Affairs, non-resident High Commissioner to Pakistan and non-resident Ambassador to Iran. Mr. Ong also serves as Chairman of the Singapore International Foundation (SIF).

Mr. Ong was Secretary-General of the Association of Southeast Asian Nations (ASEAN), based in Jakarta, Indonesia from January 2003 to January 2008.

Mr. Ong started his diplomatic career in 1979. He served in various diplomatic posts in Saudi Arabia, Malaysia, the United States of America, India and Nepal. He was Press Secretary to the then Prime Minister of Singapore, Mr. Goh Chok Tong. At the same time, Mr. Ong held senior appointments in the Ministry of Information, Communications and the Arts, and the People's Association in Singapore. From 2008 to 2011, he served as Director of the Institute of Policy Studies (IPS) in the Lee Kuan Yew School of Public Policy at the National University of Singapore.



**Ms. Sri PALUPI** is the founder of the Institute for Ecosoc Rights, where she is also one of the researchers. A graduate of Bogor Agricultural University, she is known as an activist and researcher with extensive experience in advocating social and women's rights.

Currently, Sri Palupi is involved in various social researches across Indonesia, with particular interest in migrant workers' issues, hunger, and the "right to the city" among economically disadvantaged people in Jakarta, Indonesia.



**H.E. Ms. Lily Dorianty PURBA** is the Chairperson of the ASEAN Commission on the Promotion and the Protection of the Rights of Women and Children (ACWC) and the Indonesian Representative for ACWC – Women's Rights. She is a freelance gender consultant who is currently working as a gender advisor/expert for national and international NGOs in Indonesia. She has been working for over 25 years on the ground in Indonesia. Her background includes gender equality, women and human rights, migrant workers, community empowerment and advocacy.

She graduated from the Faculty of Social Political Sciences of the University of Indonesia and holds a master's degree in Development and Gender from the University of East Anglia in the United Kingdom. She has helped many international and national organizations in conducting assessment, monitoring and evaluation of their development projects. Since 1994, she has been providing

trainings on women's rights, violence against women, gender responsive budgeting and strategic planning.

Lily started her career in the social movement in Jakarta with Urban Community Mission in 1998, where she worked with labour factory workers for organising, training and advocacy. Between 2003 and 2006 she worked in Komnas Perempuan (the National Commission on Violence Against Women) as national commissioner and was responsible for human rights training with gender perspective and for trainings on gender based violence. She also worked as manager for the Social Gender Integration Fund at PSU-CIDA (Canada International Development Agency), managing grants and monitoring project results. She also worked as deputy director for a regional NGO, Asian Migrant Center, in 2009.



**Ms. Theary SENG** is a Cambodian-American lawyer, prominent human rights activist, and an author. She is the Founder and Director of the Center for Justice and Reconciliation. Theary is an Executive Committee member of the Affiliated Network for Social Accountability in the East Asia & Pacific (ANSA-EAP), which is overseen by the Ateneo School of Government. She is a member of the World Forum for Democratization in Asia (WFDA), the World Movement for Democracy, and the Non-Governmental Process of the Community of Democracies. Theary was a Board member of the Cambodian Living Arts (Silapak Khmer Amatak, which produced *Where Elephants Weep*), and co-founder and former Vice-President of the Women's Association of Small & Medium Businesses (WASMB) in Cambodia.

Theary graduated from Georgetown University's School of Foreign Service (Washington, DC) with a degree in Bachelor of Science in International Politics in 1995, and from the University of Michigan Law School with a Juris Doctor in 2000. Theary is a member of the New York Bar Association and American Bar Association.



**Mr. Christoph SPERFELDT** is Deputy Director at the Asian International Justice Initiative (AIJI), a collaboration of the WSD HANDA Center for Human Rights and International Justice at Stanford University and the East-West Center, where he is responsible for coordinating regional programs throughout Southeast Asia. Prior to this, Sperfeldt was Senior Advisor with the Gesellschaft für Internationale Zusammenarbeit (GIZ) in Cambodia. He is also a PhD Scholar at the School of Regulation and Global Governance (RegNet) at the Australian National University.





**Prof. Dr. dr. Ketut SUASTIKA, Sp.PD.KEMD.** is the Rector of Udayana University. He is a medical specialist in endocrinology-metabolism, with extensive experience in Type 2 Diabetes and obesity.



**Ms. Pitchanuch SUPAVANICH** is a Senior Officer at the ASEAN Socio-Cultural Community Department, ASEAN Secretariat. Previously she was a Senior Officer at the Social Welfare, Women, Labour and Migrant Workers Division of the ASEAN Secretariat. She has worked as Senior Program Officer (Human Security) for the Australian Aid Program of Australia's Department of Foreign Affairs and Trade, focusing on regional programs. She was also a Grants Manager of International Rescue Committee as well as an Acting Senior Program Officer and Project Officer of AusAID. She has worked with the World Food Programme, Royal Thai Police, and the British Council. Ms.

Supavanich holds master degrees on international relations and on international migration.



**H.E. Dr. Dinna WISNU** is the Representative of Indonesia to the ASEAN Intergovernmental Commission on Human Rights (AICHR). She serves as the Director of Paramadina Graduate School of Diplomacy and was the Co-founder of the Master Degree program in Social Policy at the Faculty of Public Health, University of Indonesia. She has advised the government of Indonesia on various projects on social protection and economic development, including as a member of the Working Group on Healthcare at TNP2K (National Team to Accelerate Poverty Alleviation), as a consultant for BAPPENAS, and as the Chair of the Working Group on Health and Manpower of the Transition Team of

President Joko Widodo and Vice President Jusuf Kalla. Since 2010, she has been advising the Republic of Indonesia, particularly the Ministry of Foreign Affairs and Ministry of Defense, on various aspects of foreign policy and diplomacy. She has also worked as a consultant for a number of international organizations, including the International Labour Organization and United Nations Economic and Social Commission for Asia and the Pacific (UN-ESCAP), focusing on projects related to social protection development.

She has advised the government of the Democratic Republic of Timor Leste (Ministry of Social Solidarity) on national social protection programs and the Parliament of Cambodia (Commission VIII on Healthcare, Women and Veteran) on lessons learned in building a universal health insurance system. She has conducted various research on political economy and social protection.
